Dear Sir or Madam:

We have been retained by the City of Chicago to coordinate and oversee an information-gathering session for construction vendors on the City's Minority and Women-Owned Business Enterprise (M/WBE) Construction Program. These sessions are part of the City's review of its M/WBE Program. These information-gathering sessions will provide construction vendors with an opportunity to relate their experiences with the City and involvement in its M/WBE Construction Program. Your insight and experience will help to identify any needed improvements and support the City's goals for this program.

There will be five Group Interview sessions ("Group Interviews") concerning vendors' experiences conducting business (or attempting to conduct business) as construction vendors in the Chicagoland area. Each Group Interview session will be arranged by demographics. There will be one Group Interview session for each of the following groups: (1) African American construction vendors; (2) Hispanic American construction vendors; (3) Asian American and Native American construction vendors; (4) Non-Minority Women construction vendors; and (5) Non-Minority Men construction vendors.

In addition, there will be two Focus Group Sessions ("Focus Groups") that will similarly discuss vendors' experiences conducting business (or attempting to conduct business) as construction vendors in the Chicagoland area. The two Focus Groups are arranged by the following demographics: (1) M/WBE Primes and Subs Focus Group Session; and (2) Non-M/WBE Primes and Subs Focus Group Session.

You are welcome to attend both the Group Interview session and Focus Group session that fit your demographics. Please note, however, that each Focus Group session will be limited to 40 participants, and those spots will be distributed on a first-come, first-serve basis.
